1. This consent is given to FIDESIS Limited Liability Company (FIDESIS LLC), TIN 7725692471, OGRN 772501001, location 115114, Moscow, ul. Letnikovskaya, 5, floor 4, room I, com. 17.
2. The consent applies to the following personal data of the user:
 - surname, name, patronymic;
 - email address.
3. The consent to the processing of personal data is given by the user for the purposes of:
 - user identification;
 - personal communication with the user if necessary, including sending notifications, requests and information, as well as processing requests and requests from the user.
4. The user gives the consent to FIDESIS LLC to collect, systematize, accumulate, store, clarify (update or change), use, distribute, transfer to third parties, depersonalize, block and destroy personal data.
5.  - the periods of storage of personal data are determined in accordance with the requirements of the legislation of the Russian Federation, as well as the duration of the consent of the subject to the processing of his personal data;
